



JG SPEEDFIT PHOTO & VIDEO COMPETITION TERMS AND CONDITIONS

1. INFORMATION ABOUT US

- 1.1 This competition is being run and promoted by Reliance Worldwide Corporation (UK) Limited (referred to as “we”, “us”, “our” in these Conditions).
- 1.2 Our registered office is at Horton Road, West Drayton, Middlesex, UB7 8JL.

2. THE COMPETITION

- 2.1 The title of the competition is the “JG Speedfit Photo and Video Competition” (the “**Competition**”).
- 2.2 The Competition will be advertised and promoted on our JG Speedfit Facebook social media platform and by email marketing. The rules which apply to the Competition are as set out in these terms and conditions (the “**Conditions**”).
- 2.3 The Competition is aimed at professional plumbers or tradespeople that install our products (“**you**”, “**your**”), and will offer the opportunity for you to win a prize at the end of each Competition period.
- 2.4 The Competition will run for 2 months from 1 October 2024 to 30th November 2024 (the “**Competition Period**”) with a monthly main winner and runner up selected at the end of each month by way of a random prize draw.
- 2.5 Entries must be made by no later than 11:59pm (UK time) on the final day of the Competition Period (“**Closing Date**”). All entries received after such time on the relevant Closing Date are automatically disqualified.

3. HOW TO ENTER

- 3.1 The Competition is comprised of two parts with a main prize draw winner and a runner up selected each month.
- 3.2 In order to enter the Competition, prior to the deadline specified in clause 2.5 above, you will need to do one of the following:
 - 3.2.1 On [JG Speedfit's Facebook page](#), upload an installation photo or video of one of our JG Speedfit products to the pinned competition post as a comment. For an extra entry into the prize draw, please comment on your experience of installing our JG Speedfit product.

- 3.2.2 Email your JG Speedfit installation photo or video to marketing.uk@rwc.com, along with your name, company name and permission for us to publish on our social media platforms on your behalf.
- 3.3 Do not submit any photo or video that could be deemed rude or offensive or that violates Facebook's Terms of Use or Statement of Rights and Responsibilities. We reserve the right to disqualify any entrant submitting an entry which, in the opinion of the judges, includes objectionable content.
- 3.4 The photo or video submitted must have the permission of all individuals in the photo before it is entered in the Competition, and the entrant must own the copyright of the image it submits and warrants us that it has obtained all relevant consents of third persons contained in the image with respect to the use and publication of the image.
- 3.5 Entrants confirm and promise that their entry is an original and unpublished work and does not infringe the rights of any other person.
- 3.6 There is no limit to the number of entries you are permitted to make, provided that those entries are of different installation shots and are made prior to the deadline set out in 2.3 above.
- 3.7 Entry in the Competition is free (excluding internet connection charges).
- 3.8 We will not accept responsibility for Competition entries that are deleted or are otherwise unavailable to be viewed by us regardless of cause, including, for example, as a result of any technical malfunction, network, server, computer hardware or software failure of any kind.
- 3.9 By entering this free prize draw competition, all participants will be deemed to have accepted and be bound by these Conditions.

4. DECIDING THE WINNER

- 4.1 The winners of each part of the Competition will be decided as follows:
 - 4.1.1 Monthly Main Prize Draw - Each month's winner to be selected by way of a random prize draw which will be carried out by us as soon as possible following the end of each month.
 - 4.1.2 Monthly Runner Up Prize Draw - The month's runner up prize draw winner to be selected by way of a random prize draw which will be carried out by us as soon as possible following the end of each month.
- 4.2 The decision of RWC is final and no correspondence will be entered into.

5. ELIGIBILITY

- 5.1 The Competition is open to all residents in the UK aged 18 years or over except:
 - 5.1.1 our employees or any employees of other companies within our group; or
 - 5.1.2 members of the immediate families or households of 5.1.1 above.

5.2 In entering the Competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. We may require you to provide proof that you are eligible to enter the Competition.

5.3 We will not accept Competition entries that are:

5.3.1 automatically generated by computer; or

5.3.2 completed by third parties or in bulk (being more than five unique entries at one time).

5.4 We reserve all rights to disqualify you if your conduct is contrary to the spirit or intention of the Competition.

- 7.1 We will contact each winner personally as soon as practicable after the relevant draw has taken place, either via direct mail message on Facebook or using the email address details they provided when entering the Competition.
- 7.2 We are required to either publish or make available information that indicates that a valid award took place. To comply with this obligation we will publish the name of the winner entry within one month of the Closing Date of the Competition.
- 7.3 If you object to any or all of your name and winning entry being published or made available, please contact us using the details set out in clause 1.3 above. In such circumstances, we must still provide the information and winning entry to the Advertising Standards Authority on request.

8. CLAIMING THE PRIZE

- 8.1 In order to claim the prize you must respond to our message on Facebook or email when we contact you to confirm that you are a winner. You must also provide your residential address, email address and telephone number for us to arrange for one of our representatives to meet with you at a convenient time at your local plumbing and heating merchant to receive the prize.
